


AND TAKE OFF FEES REGULATION) (AMENDMENT NO. 2)**

ORDER NO. 4 OF 1986

To amend the Civil Aviation (Aircraft special night landing and take off fees regulation) Order No. 44 of 1984.

IN EXERCISE of the power contained in section 3(1)(r) of the Civil Aviation Act No. 38 of 1982 I hereby make the following Order :

AMENDMENT OF ORDER NO. 44 of 1984

1. The Civil Aviation (Aircraft Special Night Landing And Take Off Fees Regulation) Order No. 44 of 1984 as amended is further amended as follows :

- (i) in section 2(a) by substituting the symbol and figure 'VT 18.000' for the symbol and figure 'VT 15.000';
- (ii) in section 2(b) by substituting the symbol and figure 'VT 9.000' for the symbol and figure 'VT 7.500'.
