An Order to provide for changes to the Parliamentary Seats and Constituencies cstablished by the Representative Assembly (Constituencies and Membership) Regulation 1979.

IN EXERCISE of the powers conferred by subsection (1) of section 67 of the Representation of the People Act No. 13 of 1982, as amended, and acting in accordance with the advice of the Electoral Commission, I hereby make the following Order :-

CHANGES TO AND REPLACEMENT OF PARLIAMENTARY CONSTITUENCIES AND SEATS The Parliamentary Constituencies and Seats established by the Representative Assembly (Constituencies and Membership) Regulation No. 22 of 1979 are hereby changed and replaced.

NUMBER OF CONSTITUENCIES

For the purpose of the election of members to Parliament the Republic of Vanuatu shall be divided into 15 Constituencies, the names and boundaries of which are set out in the Schedule hereto.

NUMBER OF PARLIAMENTARY SEATS

Parliament shall consist of 46 members the seats of whom shall be distributed among the Constituencies in accordance with and in the manner as set out in the Schedule hereto.
