## THE CIVIL AVIATION (REGULATIONS) (AMENDMENT) ORDER No. 32 OF 1988

To amend the Civil Aviation (Regulations) Order No.22 of 1984.

IN EXERCISE of the powers conferred by section 8 (1) of the Civil Aviation Act No.38 of 1982, I make the following regulations:-

#### AMENDMENT OF ORDER No.22 OF 1984

- The Civil Aviation (Regulations) Order No.22 of 1984 as amended, is further amended in section 5 as follows:-
  - (a) at the end of paragraph (e) by the substitution for "." of ";";
  - (b) by the addition after paragraph (e) of the following paragraph:-
    - "(f) Civil Aviation Security Directives (CASD) outlining procedures and requirements relating to aviation security and disseminating instructions, generally to ensure the security of personnel, equipment, buildings and installations for the purpose of providing for the safety, efficiency and regularity of air navigation and the safety of aircraft and of persons and property carried thereon."

#### COMMENCEMENT

2. This Order shall come into force on the day of its publication in the Gazette.
