

CHAPTER 146

REPRESENTATION OF THE PEOPLE
(POLLING DISTRICTS) ORDER NO. 16 OF 1991

An Order to establish polling districts and polling stations.

IN EXERCISE of the powers conferred upon the Electoral Commission by Sections 4 and 69 of the Representation of the People Act [Cap. 146], the Electoral Commission hereby makes the following Order:-

REPEAL OF REGISTRATION AREAS ESTABLISHED UNDER J.R. 19 of 1979.

1. (1) The registration areas established under Section 4 of the Election regulation No. 19 of 1979 published in the Official Gazette No. 415 dated 7 November, 1979 is hereby repealed.

(2) The repeal referred to in subsection 1 shall apply to all other Orders made by the Commission amending the said registration areas established under the Joint Regulation referred to in subsection (1).

POLLING DISTRICTS

2. (1) The polling districts shall be such places as are specified under the various Constituencies set out in the Schedule to this Order.

(2) For the purposes of this Order the polling districts specified by names in the Schedule hereto are designated polling stations in respect of each polling district for the purpose of elections.

COMMENCEMENT

3. This Order shall come into force on the day of its publication in the Gazette.
