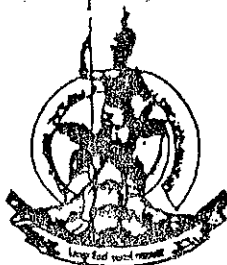

DECENTRALISATION (Nouvelle date d'élection
au CONSEIL PROVENCIAL DE SANTO/MALO

ARRET N° 19 DE 1991

Fixant les nouvelles dates et heures de scrutin à trois bureaux de vote des secteurs électoraux de FANAFO/CANAL et du Sud SANTO pour l'élection des conseillers provinciaux de Santo/Malo.

Attendu que :

a) Le président du bureau de vote a estimé que certaines circonstances ne permettraient pas que les élections se déroulent dans un délai raisonnable au bureau de vote de Port Benier dans le secteur électoral de FANAFO/CANAL, et a en conséquence suspendu les élections audit bureau de vote.
Le Directeur du Bureau électoral a été informé de cette situation et en a fait part au Conseil des élections.

Les résultats de FANAFO/CANAL ne risquaient pas, dans l'ensemble, d'être sensiblement modifiés par l'ajout des électeurs du bureau de vote de Port Benier.

b) Les élections n'ont pas eu lieu aux bureaux de FORTSENAL et TAVIMOL au Sud-Santo à cause d'évènements imprévus.

DE CE FAIT, LE CONSEIL DES ELECTIONS

VU les pouvoirs que lui confèrent l'alinéa a) du paragraphe 2) de l'article 8 de la Loi relative à la Décentralisation (CAP. 127)* telle que modifiée et les paragraphes 3) et 4) de l'article 14 de l'Arrêté N° 61 de 1982 relatif aux règles de Procédure des élections des Conseillers provinciaux

ARRETE

ANNULATION DES ACTES

1. Tous les actes posés avant que le président n'ait déclaré l'interruption des élections au bureau de vote de Port Benier du secteur électoral de FANAFO/CANAL, le mercredi 22 août 1991, sont nuls et non avenue, et une nouvelle élection y aura lieu.

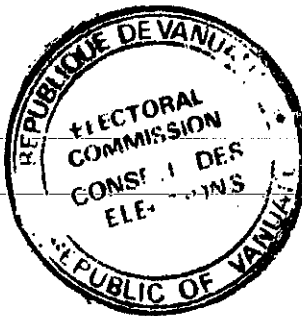

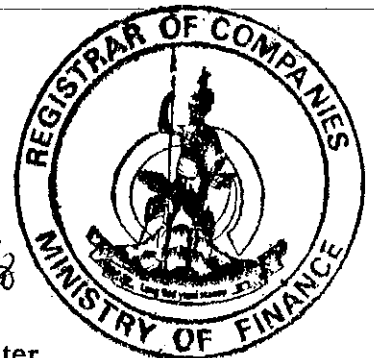

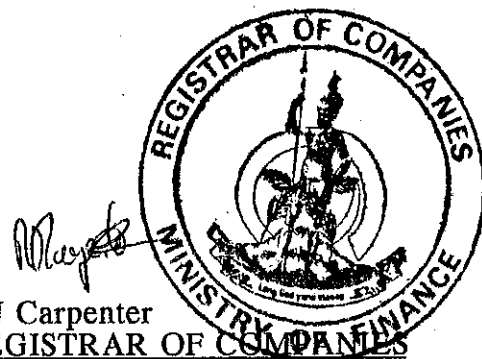
