VANUATU COMMODITIES MARKETING BOARD ACT [CAP. 133]

THE VANUATU COMMODITIES MARKETING BOARD (PRESCRIBED COMMODITY) (KAVA) ORDER NO.22 OF 1998

An Order to revoke Order No. 14 of 1998 and to reinstate Kava as a prescribed commodity.

IN EXERCISE of the power conferred to me by section 3 of the Vanuatu Commodities Marketing Board Act [CAP. 133], **I, JAMES BULE,** Minister of Trade and Business Development, after consultation with the Chairman of the Vanuatu Commodities Marketing Board, declare as follows: -

PRESCRIBED COMMODITY (KAVA) ORDER NO. 14 OF 1998

1. That Order No. 14 of 1998 removing Kava as a prescribed Commodity is hereby revoked.

KAVA REINSTALLED AS A PRESCRIBED COMMODITY

2. That Kava is hereby reinstated, by virtue of this Order, on to the prescribed Commodity list for the purposes of section 2 of the Act.

COMMENCEMENT

3. This Order shall come into force on the date hereof.
