Prohibition on the importation of Copra (Amendment)

Order No. 14 of 2004

An Order to amend the Prohibition on the importation of Copra Order No.8 of 2004.

In exercise of the powers under subsection 15(3) of the Interpretation Act [CAP 132] and the power implied by law under subsection 2(1) of the Import of Goods (Control) Act [CAP. 176] to amend an Order made under that Act, I, the Honourable Willie Jimmy Tapangararua, Minister of Commerce, Industry and Tourism make the following Order:

The Prohibition on the importation of Copra Order No.8 of 2004 is amended as set out in the Schedule.
