#### 1 Definition

In this Order unless the contrary intention appears: "Commission" means the Commission of Inquiry established under this Order.

#### 2 Appointment of Commissioner to the Commission

#### 3 Appointment of Assessors of the Commission

The following persons are appointed as Assessors of the Commission:

- (a) Superintendent Willie Samuel;

- (d) Sergeant Edmon Oswel;
- (e) Kalfau Moli.

#### 4 Terms of Reference

- (1) The terms of reference of the Commission are as set out in the Schedule 1 of this Order.
- (2) The Terms of Reference of the Commission may be amended or varied by the Minister in consultation with the Commissioner.

### 5 Location of Inquiry

The Inquiry is to be made in Port Vila and at such other place or places as the Commission may determine.

### 6 **Public or Private Inquiry**

The Inquiry is to be held in public except in circumstances as directed by the Commission.

#### 7 Reports

The Commissioner must prepare the following reports:

- (a) a report of the proceedings and of the result of his Inquiry to the Prime Minister, as the Minister of Justice not later than 7 October 2004.
- (b) a report summarizing his findings and his recommendations available to the public not later than 14 days after submission of his report to the Prime Minister.

#### 8 Commencement

This Order commences on the date on which it is made.

The declaration/publication/announcement of candidates be made on: Monday 25<sup>th</sup> day of October 2004.


