

SHIPPING ACT [CAP 53]

Seafarer's service record list Order No 18 of 2006

In exercise of the powers conferred on me by section 45 of the Shipping Act [CAP 53], I, the Honourable EDWARD NIPAKE NATAPEI, Minister of Infrastructures and Public Utilities make the following Order:

1 Requirement to keep Seafarer's service record list

- (1) All ship owners, ship operators or captains of vessels registered under the Vanuatu domestic flag and operated under a business license shall file with the Vanuatu Maritime Authority on a monthly basis a seafarer's service record list as set out in the Schedule to this Order.
- (2) A copy of the monthly seafarer's service record list shall be kept on board at all times.

2 Enforcement Officers

The Commissioner of Maritime Affairs and the licensing officers are responsible for the enforcement of this Order.

3 Penalty for breach of Order

A ship owner, operator or captain of any vessel who fails to comply with clause 1 of this Order is guilty of an offence punishable on conviction to a fine not exceeding VT20, 000.

Commencement

This Order commences on the date on which it is made.

INSTRUMENT OF DETERMINATION OF REMUNERATION OF THE VALUER-GENERAL

IN EXERCISE of the powers given under section 2 of the Schedule 1 of the Valuation of land Act No.22 of 2002, and subject to the provisions of any other enactment, the Judicial Service Commission hereby determines the Remuneration of the Valuer-General as follows:

1. REMUNERATION

The government will pay the Valuer-General an annual salary and allowances fortnightly and other Benefits.

1.1 Salary

The amount of the annual salary is VT1,421,400.

1.2 Allowances and Other Benefits

The Valuer-General will be entitled to the following allowances and other benefits:

- (a) A furnished house at rental fixed by government OR alternatively Housing Allowance of 30,000 per month until a government accommodation is provided.
- (b) Use of one car for official duties maintained and serviced at government expenses.
- (c) Child Allowance of VT1,200 a month per child.
- (d) A gratuity payable at the rate of one twelfth of the annual salary for each year which you hold the office and pro-rata of one and unemployed year.
- (e) Annual leave calculated at the rate of one and three-quarter working days for each month of service.
- (f) Entertainment Allowance of VT12,000 per month.
- (g) The payment or the reimbursement of the actual costs of Transport between Port Vila and the home island and the return journey by the most direct route on home leave.
- (h) Costs of living of VT5,000 per month.

- (i) Domestic travel costs of VT1,700 per day subsistence allowance costs.
- (j) Overseas travel costs:
 - (i) In the Pacific Region VT8,500.
 - (ii) In other regions VT13,300.
- 2. This instrument is deemed to be executed from 20 January 2006.


