

Cooperative Societies (Cooperative Development Fund Rules)
(Amendment) Order No of 2006

In exercise of the power conferred on me by subsection 53(1) and paragraph 53(2)(f) of the Cooperative Societies Act [CAP 152], I, the Honourable EDWARD NIPAKE NATAPEI, Acting Minister of Cooperatives and Ni Vanuatu Business Development make the following Order.

AMENDMENTS OF THE COOPERATIVE SOCIETIES (COOPERATIVE DEVELOPMENT FUND RULE) **ORDER NO. 1 OF 2000**

- Paragraph 40C (2) (a) to (i)
- Repeal the paragraphs substitute
- "(2) The Committee consists of 8 members who are to be appointed for a period of 3 years, by the Minister responsible for Cooperatives.
- The Chairman of the Committee is to be elected from amongst the members of the (2A) Committee.
- The Minister may remove any of the members if the member fails to perform his (2B) or her duties as a member of the Committee."
