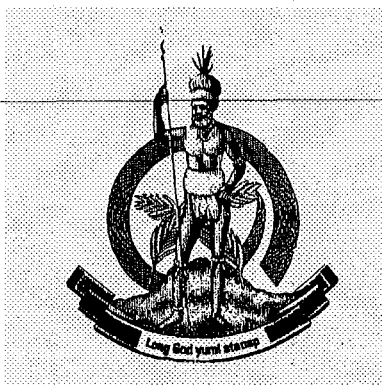

Authorisation for issue of money from the Public Fund Order No. 8 of 2008

In exercise of the powers conferred on me by subsection 39(4C) of the Public Finance and Economic Management Act [CAP 244], I, the **Honourable WILLIE JIMMY TAPANGARARUA** Minister of Finance and Economic Management, with the prior approval of the Council of Ministers, make the following Order.



1 Authorisation for issue of monies from Public Fund

- (1) The amount of VT20,000,000 (VT20 million) may be issued from the Public Fund for the:
- (a) disaster relief in Futuna Island (VT10 million); and
 - (b) disaster relief of Banks Group in Torba Province (VT10 million).
- (2) The supplementary funds are to be credited as set out in the Schedule.

2 Commencement

This Order commences on the day on which it is made.

In exercise of the powers conferred on me by subsection 39(4C) of the Public Finance and Economic Management Act [CAP 244], I, the Honourable **WILLIE JIMMY TAPANGARARUA** Minister of Finance and Economic Management, with the prior approval of the Council of Ministers, make the following Order.

1 Authorisation for issue of monies from Public Fund

- (1) The amount of VT200,000,000 (VT200 million) may be issued from the Public Fund for the establishment of the Vanuatu Agriculture Development Bank.
- (2) The supplementary funds are to be credited as set out in the Schedule.

2 Appointment of the Secretary

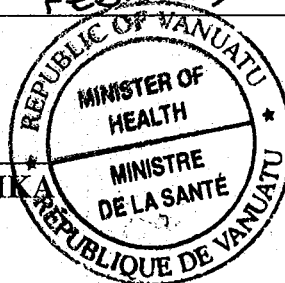
Mrs Meriam Abel is appointed as the Secretary to the Board.
