

THE EXEMPTION OF LOCALLY-BASED FOREIGN FISHING VESSELS FROM THE REQUIREMENTS OF PART 6 OF THE FISHERIES ACT

The exemption specified in this notice apply to locally-based foreign fishing vessels in accordance with clause 9 (2) of the Fisheries Regulation Order No. 28 of 2009.

1 Definitions

automatic location communicator means a device approved by the government, recognizing those approved by the Forum Fisheries Agency or relevant Regional Fisheries Management Organizations, and placed on a fishing vessel that transmits, either in conjunction with another device or devices or independently, information concerning the position, fishing activities and other related activities of the vessel;

director means the person holding the office of the Director of Fisheries from time to time;

Locally-based foreign fishing vessel means:

- (a) any foreign fishing vessel based in Vanuatu that lands all its catch in Vanuatu; or
- (b) any foreign fishing vessel based in another South Pacific country and jointly operated by or on behalf of the Government of Vanuatu and one or more Governments in the South Pacific region under an agreement to which the Government of Vanuatu is a party; or
- (c) a foreign fishing vessel fully owned and operated by a person or persons who are not citizens of Vanuatu, which is chartered by a person or persons who are citizens of Vanuatu to fish in Vanuatu and land all its catch in Vanuatu.

mobile transmission unit has the same meaning as automatic location communicator;

regional register means the register of foreign fishing vessels as administered by the South Pacific Islands Forum Fisheries Agency (FFA);

Tuna Fishing (Vanuatu) Company Limited means the locally incorporated company pursuant to the Companies Act (CAP 191) with company registration number, **5596**

vessel monitoring system means any system to monitor the position and activities of fishing vessels for the purpose of effective management of fisheries, and within the meaning of this Notice, the Forum Fisheries Agency vessel monitoring system;

2 Vessel Monitoring System

- (1) The locally-based foreign fishing vessel, Anegra, chartered to Tuna Fishing (Vanuatu) Company Limited, is hereby exempted from:
 - (a) the requirement to participate in the vessel monitoring system and the regional register;
 - (b) the requirement to install, maintain, and operate a FFA Type Approved automatic location communicator;




