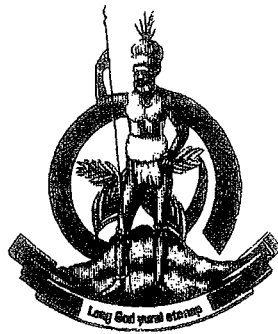

Liquor Licensing (Prohibition Of Sale)
Order No. ~~15~~ Of 2009

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52], I, the Honourable SATO KILMAN, Deputy Prime Minister and acting Minister of Internal Affairs make the following Order.

1 Sale of Liquor Prohibited

The sale of liquor in or from licensed premises throughout Vanuatu whether for consumption on or off such premises is prohibited from 12 mid night on Wednesday 30th December 2009 to 12 mid night Friday 1st January 2010.

2 Exemption

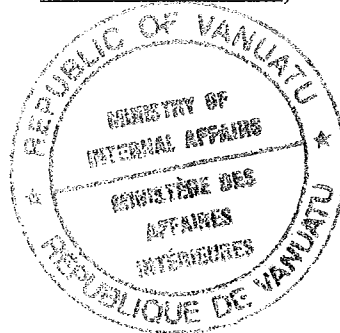
Liquor may be sold during the period referred to in section 1 in accordance with section 18 of the Liquor Licensing Act [CAP 52].

3 Commencement

This Order commences on the day on which it is made.

1 Amendment

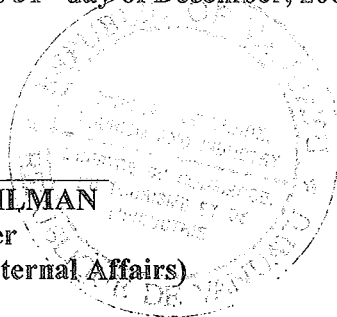
The Liquor Licensing (Prohibition of Sale) Order No.125 of 2009 is amended as set out in the Schedule.

SCHEDULE

AMENDMENTS OF THE LIQUOR LICENSING (PROHIBITION OF SALE) ORDER NO. 125 OF 2009

1 **Section 2**
Repeal the Section substitute

“2 **Exemption**

Liquor may be sold during the period referred to in section 1 within the normal hours of opening in restaurants, hotels, casinos, nightclubs and bars to bona fide customers for consumption.”
