General Directions for the Use of Fire Arms

Order No. 28 of 2010

In exercise of the powers conferred on me by subsection 4(3) of the Police Act [CAP 105], I, the Honourable PAUL TELUKLUK, Acting Minister of Internal Affairs, issue the following General Direction.

1 Direction for use of fire arms

The members of the force are entitled to carry fire arms for use only for the purposes of apprehending the escaped detainees listed in the Schedule.

2 Period of use of fire arms

The period which the members of the force are to use fire arms is to commence on the date on which this General Direction is made and ceases when the escaped detainees are arrested.

3 Commencement


