#### PHYSICAL PLANNING ACT NO. 22 OF 1986

## DECLARATION OF LENAKEL MUNICIPAL COUNCIL TO BE A PHYSICAL PLANNING AREA

**IN ACCORDANCE** with section 2 (1 & 3) of the Physical Planning Act. No. 22 of 1986 [Cap. 193], the Lenakel Town Municipal Council (LTMC) hereby declares Lenakel Municipal Area to be Physical Planning Areas (PPA) for the purpose of development in accordance with the said Act.

Subsequently, Lenakel Town Municipal Council decide that the following types of development as specified in schedule 1 of the Act shall NOT require permission for development;

#### Schedule 1

### DEVELOPMENT FOR WHICH PERMISSION MAY NOT BE REQUIRED BY LENAKEL TOWN MUNICIPAL COUNCIL (LTMC)

- 1. The carrying out of works for the maintenance, improvement or other alterations of any building if the works affect only the interior of the building and do not materially affect the external appearance of the building.
- 2. The extension on one occasion only of any building for which permission has already been given by the council by 10 percent of its net floor area.
- 3. The carrying out of works by a public authority required for the maintenance of improvement of a road if the works are carried out on land within the road reserve.

- 4. The use of any building or other land within the cartilage of a dwelling house for any purpose incidental to the enjoyment of the dwelling house.
- 5. The use of any land and associated buildings though not living accommodation for the purposes of live-stock keeping, agriculture, fishing or forestry.
- 6. Any other operations or use of land which may be prescribed in regulations made by the Minister.

Any other development that occurs within the said area, one must obtain the necessary prior consent from Lenakel Town Municipal Council.

Any person found to be in breach of this legal requirement shall be punishable by the courts according to the Act.
