CHIEF JUSTICE'S CHAMBERS

ORDER FOR 2011/2012 COURTS RECESS

IN EXERCISE of the powers conferred by Rule 18 of the Civil Procedure Rules 2002, **I HEREBY make the following ORDERS**:

- 1. That the Court Recess of 2011 shall be from 19 December 2011 to 20 January 2012.
- 2. That this Order shall apply to all courts.
- 3. That during the recess period, there will be no court sittings, except for cases or matters and/or situations requiring urgent court sittings or hearings.
- 4. That subject to (a) below, all Court Registries will remain open and operative during the court recess; and
 - a. The Court Registries shall be closed from Tuesday 27th December 2011 to 3rd January 2012.
 - b. Court cases already listed for hearing from 19 December to 30 December 2011 shall still be on unless directed otherwise by the Presiding Judicial Officer.
