#### Declaration of Candidature Order No. 66 of 2012

An Order to declare the closing date for the lodging of declaration of candidature for the general election to be held on 30<sup>th</sup> October 2012.

In exercise of the powers conferred on the Electoral Commission by subsection 25(1) and section 69 of the Representation of the People Act [CAP 146], the Electoral Commission makes the following Order:

- 1 Closing date of declaration of candidature
- (1) A person who intends to stand as a candidate for the general election to be held on 30<sup>th</sup> October 2012 to Parliament must lodge with the Electoral Office his or her candidature for the general election to Parliament in accordance with the requirements of section 25 of the Representation of the People Act [CAP 146] ("the Act").
- (2) The person's candidature must be lodged with the Electoral Office not later than 19<sup>th</sup> September 2012 at 4.30pm.
- (3) The person must be qualified and eligible as required by sections 23A, 24 and 25 of the Act.
