Trademarks For Goods and Services (Fees) Regulation Order No. 15 Of 2012



Decision 01 of 2012 NOTICE NO. 10 OF 2012

In exercising the powers and duties confer to me under Section 27(1) of the Telecommunications and Radiocommunications Regulation Act No. 30 of 2009 ("the Act"), I, the Regulator make the following Orders:

- 1. The Regulator hereby notifies Digicel (Vanuatu) Limited ("Digicel") that Digicel is hereby determined to be a nominated service provider under Section 27(1) of the Act.
- Pursuant to Section 27 of the Act and the above nomination, Digicel is required, within 90 days, to propose the terms and conditions of a reference interconnection offer for the provision of interconnection services by Digicel.
- The Regulator requires the proposed terms and conditions of Digicel to relate to interconnection services for all mobile and fixed services offered or supplied by Digicel to one or more customers in Vanuatu.
- 4. The Regulator hereby notifies Telecom Vanuatu Limited ("TVL") that TVL is hereby determined to be a nominated service provider under Section 27(1) of the Act.
- Pursuant to Section 27 of the Act and the above nomination, TVL is required, within 90 days, to propose the terms and conditions of a reference interconnection offer for the provision of interconnection services by TVL.
- The Regulator requires the proposed terms and conditions of TVL to relate to interconnection services for all mobile and fixed services offered or supplied by Digicel to one or more customers in Vanuatu.
