#### Liquor Licensing (Prohibition of Sale) Order No. 47 of 2013

To provide for the prohibition on the sale of liquor throughout Tanna island.

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52], I, the Honourable PATRICK CROWBY MANAREWO, Minister of Internal Affairs, make the following Order.

#### 1 Sale of Liquor prohibited

The sale of liquor in or from licensed premises throughout Tanna island whether for consumption on or off such premises is prohibited from 12 o'clock midnight on Sunday 26<sup>th</sup> May 2013 to 12 o'clock midday on Tuesday 28<sup>th</sup> May 2013.

#### 2 Exception

Liquor may be sold during the period referred to in clause 1 within the normal hours of opening in restaurants, bars and hotels to bona fide customer for consumption with food.

#### 3 Commencement

This Order commences on the day on which it is made.






