
1 Amendments

 - (b) Mr. Dick Abel as the Deputy Chairman of the Council.

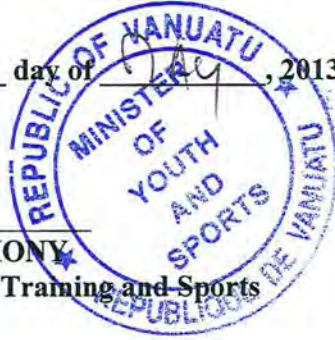
