TOURISM COUNCILS ACT NO. 23 OF 2012

Provincial Government Tourism Council Sitting Allowance Order No. 14 of 2014

In exercise of the powers conferred on me by subsections 19 (1) and (2) of the Tourism Councils Act No. 23 of 2012, I, the Honourable TOARA DANIEL KALO, Minister of Tourism, Trade, Commerce and Ni-Vanuatu Business make the following Order.

1 Sitting Allowance

Subject to clause 2, the amount of sitting allowances payable to each member of a Provincial Government Tourism Council is VT5,000 for each day on which a council sits for a meeting.

2 Provincial Government Tourism Councils entitled to sitting allowances

A member of the following Provincial Government Tourism Councils is entitled to a sitting allowance referred to in clause 1:

- (a) the Tafea Tourism Council; and
- (b) the Shefa Tourism Council; and
- (c) the Sanma Tourism Council; and
- (d) the Malampa Tourism Council; and
- (e) the Penama Tourism Council; and
- (f) the Torba Tourism Council.

Signs not to be used as Trademarks Order No. 16 of 2014
