The Narcotics Laboratory was officially opened on the 31st July 2013; with the keynote address given by Prime Minsiter Tuilaepa Sailele Malielegoai.The \$40,000 lab is a joint venture between SROS, the Attorney General's office and the Ministry of Police and Prisons in a bid to provide international quality narcotics testing for the people of Samoa.At present the lab is only equipped to test marijuana and SROS has two authorised analysts that can test the narcotic.Tuilaepa said this project is an example of what Samoa can do when its agencies come together and approach a problem with a 'whole of government' approach.

"The Law and Justice Sector agencies came together and identified a problem with our fight against narcotics," he said.He said the project was implemented by a group that included the Police, Public Works, Health, SROS and led by the office of the Attorney General. "To enforce and successfully prosecute narcotics cases is dependent on a number of things and one of the key components is having a lab to test narcotics confiscated by the police.We acknowledge the role of the SROS here at Nafanua the new home of our narcotics lab.There will be challenges that come with a narcotics lab thank you for taking up that challenge."

On the day of the opening, SROS CEO Tilafono David Hunter said the benefits of having a local lab are not only reliability but also cheaper testing.He said while SROS is a government body it provides independent testing for other government agencies and is looked at as an independent laboratory.

"So that clears the issue of integrity and bias," he said. "It's really to localise the service and for government and for Samoa to be able to provide this kind of testing service rather than sending the samples overseas."



The CEO said this new laboratory is the first step in the long term plan for the lab. "We are working on long term plans where we are going to equip the lab with the necessary equipment to test harder drugs such as ice."

Court cases are (scheduled) at a time according to the availability of analysts overseas. "But now we are here we go by the schedule of the cases and also it's cheaper now to test it here, because it really costs the Ministry of Police and Prisons a lot of money to send their samples overseas."





"It required the authorised analyst in a NZ institution to come over and that's all paid for by the Police. As with here, we only charge the Ministry of Police and Prisons the cost of testing the sample."

That procedure was followed until five years ago, when New Zealand testing was replaced with local testing at the Alafua campus of the University of the South Pacific.

> General Attorney Aumua Ming Leung Wai said that there was now a new procedure to follow. "This arrangement between the Ministry of Police and Prisons and the University of the South Pacific at Alafua will no exist the lonaer as construction of the new Narcotics Laboratory at the SROS compound at Nafanua has been completed," he said.



"I thank the University of the South Pacific for the last five years in their contribution to the Law and Justice Sector of Samoa; due to their assistance, Samoa is now able to have a lab of its own. I thank the Government of Australia for its support, as this project is funded with Australian aid via the Law and Justice sector." Taliafono said SROS achieved international accreditation certification in 2011 which means the tests they provide here are internationally recognised.

He said now that the organisation is internationally recognised the intention was to relocate the testing service from the University which is a regional organisation and further localise it by a local research institute or research organisation such as SROS.

So a year ago they approached the AG's office with a project proposal to seek funding."It took about five weeks to build the laboratory to spec," he said."We had to partition and build it in such a way that it is very secure." "Now that is built, only authorised analysts are allowed to go in." The CEO said this new laboratory is the first step in the long term plan for the lab."We are working on long term plans where we are going to equip the lab with the necessary equipment to test harder drugs such as ice," he said, referring to methamphetamine. "We have to ensure that our scientists attached to the lab also undergo further training. "The more you deal with hard drugs, especially ice; [there] is a lot of detailed analysis.So the more we move to hard drugs the more training our scientists will need to undergo."



New Judge Sworn In

The country's newest judge has been praised for earlier contributions to the reformation of law in Samoa as being "bold, practical and ... liberal." Tafaoimalo Leilani Tuala-Warren was sworn in on Friday, August 23rd, 2013, at Mulinu'u as a new District Court Judge, only the third woman to be appointed to the Courts in Samoa. Her Honour Judge Tafaoimalo joins two others at the District court. She took her oath and signed warrant papers at the Supreme Court in front of dozens of friends, family and colleagues. His Honour Chief Justice Patu Falefatu Sapolu called on the new judge to serve "without fear or favour." His Honour Patu also stressed that normal life means love for family, helping friends, and making decisions so that others will not hate you - but as a Judge, you have to stand by your oath to the Court. "You depend on God to give you strength and guide you along the way. Because all those things that you have in life before you become a Judge will be taken away, and you stand alone." Congratulating Judge Tafaoimalo, the Attorney General Aumua Ming Leung Wai spoke of her dedication to the legal fraternity, most recently as head of the Samoa Law Reform Commission.

Returning from overseas in 2008, Tafaoimalo accepted an appointment with few resources. "She took up the challenge with no staff, no car and no office," said Attorney General Aumua. "She built up the Law Reform Commission from scratch and after two years of perseverance and hard work she had established a commission that was fully staffed and well resourced and equipped that was able to stand on its own, she produced law reform reports to Government and the Legislative Assembly that were bold, practical and, in a sense, liberal, her reports exposed the country to a different way of thinking and at times, stimulated debate about our cultural and Christian beliefs." He also praised her for conducting extensive consultations. "Areas requiring major law reform were taken by Tafaoimalo to our people at the grassroots level in order to hear their views. "Public consultations all around Samoa resulted in the drafting of laws and bills, which had the input of our people such as the New Crimes Act 2013, Lawyers Bill and Village Fono Amendment Bill."

Many turned up to witness the swearing in of Judge Tafaoimalo. Along with the Chief Justice and Attorney General, there were all the justices from the Supreme Court, District Court judges, the President of the Lands and Titles Court together with close friends and relatives. Rev. Elder Peteru Tone led the ceremony while staff from the Ministry of Justice sang hymns before the swearing in. "I, Tafaoimalo Leilani Tuala-Warren, swear by Almighty God, that I will well and truly serve the Independent state of Samoa, in accordance with the Constitution and law, and I will do right in all manner of people, without fear or favour, affections or ill will, so help me God". Tafaoimalo attended Waikato University where she graduated with her law degree and later on a Masters of law degree.

She joined the Office of the Attorney General after her studies before she returned to Waikato University and lectured there for a few years before coming back to Samoa and joined her brothers' law firm of Tuala and Tuala. Judge Tafaoimalo thanked her many friends and family who were present to witness her being sworn in as a District Court Judge. Soalaupule Graduates Celebrate

There was singing, laughing and celebrating at the Ministry of Justice and Courts Administration on 4 September when the 21 participants in the Soalaupule (Samoan Customary Mediation) Course received their completion certificates at an award ceremony.

> Tagaloa D.C. Kerslake, President of the Land and Titles Court, presented the certificates together with fellow course instructors Professor Aiono Dr Fanaafi and Associate Professor Selene Mize from the Faculty of Law at the University of Otago.

> Associate Professor Mize said that she had been teaching dispute resolution for 25 years and that Samoa is fortunate to have mediation as a part of its culture. This culture of consensus is an alien concept to most of the students she has taught over many years, but not to Samoans. At the conclusion of her address, Associate Professor Mize presented to his Honour Patu Falefatu Sapolu, Chief Justice of the Supreme Court of Samoa, and a book for the Supreme Court library.

In a video address, Professor Mark Henaghan, Dean of the Faculty of Law at the University of Otago, congratulated the graduates.

'You are the most wonderful, warm, friendly people and I know that you've worked hard in this course. You live in the most beautiful place in the world,' he said.

He emphasised that mediation is a very important way of resolving disputes: it allows parties of a dispute to feel that they have been heard and that they can accept the outcome because they have been involved in reaching that resolution.

'Mediation allows people to work through their differences and come to a result that they can live with,' he said.

Taefu Lemi, Associate Minister of Justice, delivered a fun-filled speech on behalf of the student group. Twenty one (21) members were given certificates, 17 whom were Ministry of Justice employees, including their CEO, plus the PSC CEO, Associate Minister of the Ministry of Justice, Law and Justice Sector Coordinator, a senior Sergeant from the Ministry of Police and a representative from the Office of the Ombudsman.

The Soalaupule course ran from 11 July to 3 September 2013 as a joint initiative of the Ministry of Justice and Courts Administration, the University of Otago (New Zealand) and the Samoa Law and Justice Sector.

The course was aimed at mediators who deal specifically with mediation for the Land and Titles Court. The Land and Titles Act 1981 stipulates that Samoan mediation (soalaupule) of all matters involving customary land and matai titles is mandatory before filing any application for a court order.

The course instructors were Associate Professor Mize, Tagaloa D.C. Kerslake, President of the Land and Titles Court, Professor Aiono Dr Fanaafi, President of Le lunivesite o le Amosa o Savavau (Inc.) (the Samoan Indigenous University), Rev. Elder Tautiaga Senara, Deputy Chairman of the Congregational Christian Church of Samoa (CCCS), and Rev. Uta Muaulu, Pastor for Fasitoo-Uta, CCCS.

Samoa Law Reform Commission Seeks Public Views on 'Sex Offenders Register'.

'The call for a sex offenders' register was generated by a decision made by His Honour Justice Nelson to combat sexual reoffending'

In December 2012, interest in a sex offender's register came about as a result of a Supreme Court case where a 45 year old man was convicted and sentenced to 3 years for indecent assault on a 7 year old girl. The same offender was found to have been convicted and sentenced in the same offence in 2009. Justice Nelson who presided in this case stated that:

"It may also be such time for sex offenders in this country to register so that people may know what kind of people are around their children...it is clear that this defendant learnt nothing from the first time and the chance for re-offending is high."

This public statement made by his Honour Justice Nelson has raised discussion amongst members of the public whether such reference is appropriate in the context of Samoa.

The Samoa Law Reform Commission ("Commission") received a reference from the Attorney General to enquire as to whether a sex offenders' register is appropriate for Samoa and whether it can reduce sexual reoffending.

To date, the Commission has completed the first three stages of its law reform process and these are the: Preliminary research, Discussion Paper and Consultations (Stakeholders and Public).

'The views/submissions received by the Commission will be used to form recommendations to be submitted to Cabinet for approval' To seek the views of stakeholders and the public on the reference received, the Commission carried out in three separate weeks from end of July to mid-August 2013 its stakeholder consultations. Public Consultations for both Upolu and Savaii were held in the month of October.

Media Coverage through newspaper advertisement and T. V. Programmes were some of the means that the Commission took to gauge the views of the public.

The views /submissions received by the Commission will be used to form recommendations to be submitted to Cabinet for approval.

The Commission is working towards producing a final report taking into account submissions from the public and stakeholders. This Final Report will be submitted to Cabinet for approval.
